All media, open art competition

There is no theme for this competition.

There is a limit of 4 entries per artist.

Entry fee is \$25.00 per piece.

Deadline for entry is February 6th, 2019.

Maximum size per entry is 36" x 48". No glass over 16" x 20"

2D artwork must be pre-wired and ready to hang. 3D entries must come with a pedestal.

Artwork drop off date: Thursday, February 7th, Noon to 6:30

Art pick up will be on Sunday March 3rd, from 1 to 5 PM. The doors close at 5:00.

Please note: The gallery will be open to the public during mall hours. Volunteer Gallery Attendants are needed. There is no guarantee that a Gallery Attendant will be present at all times. Gallery Attendants will receive space to hang extra artwork that they can sell while they are at the gallery.

The artist receives 100% of the sale.

Competition entries may be sold by the artist at any time during the competition. Buyer may take possession at the artist's discretion. The artist may replace a sold piece with another entry for a replacement art entry fee of \$25.00

Only artwork on display at the time of judging will be eligible for prizes.

Art Competition Guidelines

ARTIST PARTICIPANTS MUST BE A CURRENT MEMBER OF THE LAS VEGAS ARTISTS GUILD.
ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

The following are the rules for entering into the Las Vegas Artists Guild Galleria Art Expo Open Art Competition. Please read the rules and the procedures in order to apply properly. If you have any questions regarding the theme and its interpretation, please contact us at LVArtistsGuildExpo@gmail.com and we will help you with the application process.

1. Agreement to Official Rules

Participation in the Art Competition constitutes entrants full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

2. Eligibility

- a. **ARTIST PARTICIPANTS MUST BE A CURRENT MEMBER OF THE LAS VEGAS ARTISTS GUILD**
- b. 2D and 3D work are eligible.
- c. Your artwork must be your own original concept and not a copy of anyone else's copyrighted material.
- d. You may only submit your own artworks that you, personally created.
- e. If there is any question about authenticity; Galleria Art Expo Open Art Competition reserves the right to demand proof of authorship....if it's not then your entry will be disqualified.
- f. All work must be available for sale (either the original or reproduction is acceptable)
- g. **Artwork must be family friendly (No nudity) and non-political per the Galleria at Sunset.** Non-compliance and or any misrepresentation by the Participant may result in the removal of that artwork from display and or request Participant to leave the Expo. Participant forfeits any and all fees paid to LVAG.

3. Sponsor

The Las Vegas Artists Guild Galleria Art Expo Open Art Competition is sponsored by Galleria at Sunset, located at 1300 W. Sunset Road, Henderson NV 89014.

4. Art Competition Period

The Las Vegas Artists Guild Galleria Open Art Expo Art Competition begins on the February 8th at 10:00 am and ends on the March 3rd at 1:00 pm.

6. Payment of Entry Fee

Payments made online are through PayPal. The artist does not need to have a PayPal account in order to make payment. The payment option is located on the entry form on the web page. You will receive an invoice if you entered via email.

NOTE: There Will Be No Return of Any Entry Fees

7. Artwork Preparation

2D artwork must be pre-wired and ready to hang. 3D entries must come with a pedestal.

8. Criteria for Judging

Artwork will be judged based on the following elements of artistic expression:

1. Creativity and originality.
2. Quality of artistic composition and overall design
3. Overall impression of the art. What is the effect of the artwork in general and as a whole?
4. Overall, does the artwork stand on its own as a complete and outstanding work of art?

9. Judges

Judges of the Las Vegas Artists Guild Galleria Art Expo Open Art Competition will be announced upon their confirmation.

10. Use Rights

Artists who submit their artwork the Las Vegas Artists Guild Galleria Art Expo Open Art Competition agree to the following;

- a. That Las Vegas Artist Guild and Galleria at Sunset be granted usage of the artwork only for display, marketing and promotional purposes for that, and for any future Las Vegas Artists Guild Galleria Art Expo Open Art Competition and that usage of that image is limited to Galleria Art Expo Art Open Competition press releases, Galleria Art Expo Open Art Competition event presentations, Galleria Art Expo Open Art Competition articles, Galleria Art Expo Open Art Competition graphics, Galleria Art Expo Art Open Competition slide shows, Galleria Art Expo Open Art Competition presentations, Galleria Art Expo Open Art Competition event materials and for use on Las Vegas Artists Guild website.
- b. Galleria Art Expo Open Art Competition will credit each image creator with their Artist Name and Image.
- c. Otherwise, the Artist shall maintain all copyrights of any images that are submitted to Galleria Art Expo Open Art Competition.
- d. By entering this, you are granting Galleria Art Expo Open Art Competition a non-exclusive, perpetual license to reproduce images of your artwork for the sole purpose of advertising this Art Competition and your work.

11. General Conditions

In the event that the operation, security, or administration of the Galleria Art Expo Open Art Competition is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Galleria Art Expo Open Art Competition is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Galleria Art Expo Open Art Competition to address the impairment and then resume the Galleria Art Expo Open Art Competition in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Galleria Art Expo Open Art Competition and, in the event of termination, refund all entry fees paid. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Galleria Art Expo Open Art Competition or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Galleria Art Expo Open Art Competition may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorneys fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

12. Release and Limitations of Liability

By participating in the Galleria Art Expo Open Art Competition, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Galleria Art Expo Open Art Competition, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Galleria Art Expo Open Art Competition or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Galleria Art Expo Open Art Competition, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Galleria Art Expo Open Art Competition; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads, (e) any other errors or problems in connection with the Galleria Art Expo Open Art Competition, including, without limitation, errors that may occur in the administration of the Galleria Art Expo Open Art Competition, the announcement of the winner, the cancellation or postponement of the event and/or the flyover, if applicable, the incorrect downloading of the application the processing of entries application downloads or in any Galleria Art Expo Open Art Competition-related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Galleria Art Expo Open Art Competition or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties liability will be limited to the cost of entering and participating in the Galleria Art Expo Open Art Competition, and in no event shall the entrant be entitled to receive attorneys fees. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Galleria Art Expo Open Art Competition. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

13. Disputes

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Galleria Art Expo Open Art Competition or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Nevada. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Guidelines, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Galleria Art Expo Open Art Competition, shall be governed by, and construed in accordance with, the laws of Nevada, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Nevada.

15. Inclusion to Art Competitions

To be included in any and all competitions, the above-listed rules and guidelines must be agreed and adhered to.
